### Livestock Notice to Purchasers

Health & Safety - Kivells accept no liability for any damage or injury to persons, livestock, vehicles or plant not arising out of their negligence. Any person entering the livestock market premises does so at their own risk and must comply with the requirements of any Health and Safety notices. All persons entering the livestock markets premises are hereby given notice that there are potential hazards due to the type, penning, herding, loading and unloading of livestock and vehicle movement. Caution should be exercised and children must be fully supervised at all times. Kivells reserve the right to refuse admission to any person or vehicle into the livestock market premises without giving reason. Kivells strongly advise that no persons access the sale ring, pennage or livestock passageways during the sale or whilst animals are being moved through passageways. Should any person decide to enter these aforementioned areas they do so entirely at their own risk. Any incidents or accidents in the livestock market premises should be reported to Kivells market office immediately.

Biosecurity and Livestock Welfare - All persons entering Kivells livestock market premises must comply with all current Biosecurity legislation, rules and conditions. All persons should be in clean clothing and disinfect footwear upon entry and exit from the livestock market premises. Hand wash facilities, disinfectant boot dips and brushes are available and should be used. Vehicles used to transport animals to or from the livestock market premises must comply with current cleaning and disinfection legislation. All vendors, purchasers, agents and hauliers must comply with all current legislation governing the welfare of livestock whilst at Kivells livestock market premises or in transport to or from the livestock market premises. Any concerns over Biosecurity and Animal Welfare should be reported to Kivells Biosecurity and Animal Welfare officers, whose details are located in the Kivells market office.

**Registration** - In order to bid, all **new** Buyers are required to register before the auction, at the Kivells market office or as otherwise advised by the Auctioneers. All such Buyers will be asked for two forms of identification and a credit reference will be required. Acceptable identification includes Driving Licence/Passport together with a Utility Bill/Proof of Address/Business Letter Heading/Business Card. The Auctioneers reserve the right to request a deposit ahead of any purchase or during sale proceedings and to refuse registration or any bid or bidder without giving reason. New Buyers are strongly advised to contact the Auctioneers well in advance of the sale.

Payment - All Lots must be paid for on the day of the Sale by the Buyer prior to any removal or consolidation, unless alternative arrangements have been agreed with the Auctioneers. At the fall of the hammer the highest bidder will be deemed to be the Buyer and transfers of purchases will only be permitted with prior approval from the Auctioneers. Any payment is to be by a means approved by the Auctioneers. Our preferred payment terms are debit card or cash and Kivells reserve the right to stipulate payment by these methods. Kivells may also accept bank transfers and cheques with prior approval. Our Bank Account details are: Sort Code 56-00-49 Account Number 32376359.

**Payment in Cash** - In order to comply with money laundering regulations we cannot accept Cash payments above the maximum permitted at the time of sale. The maximum varies according to exchange rates and currently it is circa £9,000. Buyers are advised to check with the Auctioneers ahead of the sale.

**Conditions of Sale** - It is strongly recommended that Bidders and Buyers visit **Kivells.com** and read the full Conditions of Sale produced by the Livestock Auctioneers Association (LAA) ahead of the sale. Unless advised otherwise you will be bidding and buying under these Conditions and you will be obligated to abide by these Conditions and these Notice to Purchasers. The LAA Conditions of Sale are also displayed in Kivells market office. Clauses 12 to 19 inclusive relate mainly to the Purchaser. This catalogue may also contain reference to Warranties as defined by the LAA Conditions of Sale. Warranty issues will not be considered if payment in full has not been received.

**Risk** - All livestock are at the risk of the Vendor before they are sold and at the risk of the Buyer when they are sold (fall of the hammer). It is strongly advised that Vendors and Buyers ensure that their insurance policies cover livestock at market premises and that Buyers have immediate cover for animals purchased.

**Removal of Lots** - Lots can only be removed once payment has been made in full and/or a pass issued by the Auctioneers. All Lots need to be cleared from the sale premises by 5pm on the day of sale unless otherwise agreed with the Auctioneers.

**Descriptions of Lots** - Buyers should satisfy themselves prior to making bids as to the condition of any Lot and should rely on their own judgement as to whether the Lot accords with its description. All Lots are sold under the Livestock Auctioneers Association Conditions of Sale as referred to above to include the following two clauses:

**Statements of Fact** - Unless otherwise announced all statements of fact made in any sale catalogue or at the time of sale regarding the breeding of any animal, its health status or other tests carried out on any animal are statements of fact made by the Vendor and not the Auctioneer and the Auctioneer accepts no responsibility for any misstatement nor does he nor the Vendor accept any responsibility for any subsequent reaction by an animal sold to any relevant test administered after the sale.

Liability of The Auctioneer - The Auctioneer acts in all respects only as agent for the Vendor and no warranty is given by the Auctioneer or his employees or contractors, and none shall be implied, as to tille, description or the quality of any Lot. Neither the Auctioneer on his employees or contractors shall be liable to the Purchaser in any respect for any defect of title, error of description or imperfection or for any announcement or statement concerning any Lot offered for sale whether made orally or in writing (whether in a sale catalogue, order of sale, advertisement for the sale or otherwise) and whether given before, during or after the sale, nor shall he incur any liability in relation to any dispute between a Vendor and Purchaser.

Bidding Form - The Auctioneers will bid on your behalf if written instructions are received on the form supplied, or an email or text has been received confirming instructions and acceptance of the terms set out in the form and adequate time is available to enter such bids. The Auctioneers reserve the right to request a deposit as part of the instruction process. It is entirely at the discretion of the Auctioneers whether other forms of bids are acceptable however in every case there is no liability on the auctioneers.

### RAM SALE BYE LAWS AND

### NOTES TO PURCHASERS AND VENDORS

#### I. Selling will commence at 10 am in both rings Non MV Accredited Ring at 11.30am

- 2. All rams are sold subject to the usual Auctioneers' conditions and to the Ram Sale Bye Laws.
- All rams must be penned between <u>6.00 am and **8.30 am**</u> on the morning of the Sale or between <u>2.00 pm and 5.00 pm</u> the night before. NB: Gates are locked at 7.00 pm.

#### IMPORTANT: ALL SHEEP MUST BE IN THE MARKET BY 8.30 AM. OR THEY WILL BE EXCLUDED FROM THE SALE.THIS RULE IN VIEW OF LATE ARRIVALS IN THE PAST WILL BE STRICTLY ENFORCED.

- 4. Each lot of rams shall be sold in the ring fixed by the Committee and in order of the catalogue, and in that ring only the Auctioneer exposing such lot and the owner there shall be bound to see that the rule is carried out. Any party infringing this rule shall be liable to a penalty determined by the Committee, and for any loss or damage which may be sustained and furthermore the Committee are empowered to refuse further entries from any Vendor infringing this rule.
- 5. Each lot must be in the Sale pen to which it belongs as the last ram in the preceding lot shall have been disposed of. Any lots that may not be ready in the Sale pens when their turn for selling arrives will not be allowed to come forward until all other in that section have been disposed of.
- 6. Although help will be provided Vendors are wholly responsible for bringing their sheep to the Sale Ring and returning them to their correct pens.
- 7. All rams must be identified by their catalogue number by means of a clearly marked paint brand or by a neck tag – supplied by the auctioneers. Any ram not carrying its correct catalogue number will be refused entry to the Sale.
- 8. UNSOLD RAMS MAY NOT BE RE-OFFERED FOR SALE THROUGH THE RING apart from the unsold rams of the first two Vendors or first ten lots in each ring and they are to be re-offered at the end of that breed. If however, they are sold by private treaty after leaving the ring then the transaction must be booked through the auctioneers. The Committee will refuse entries for future sales from any Vendors infringing on this rule. The onus for responsibility for the stock remains with the Vendor at all times.
- 9. Your attention is drawn to the following:

"All rams will be subject to inspection by a panel appointed by the Committee in conjunction with the Breed Society, where applicable." A Veterinary Surgeon will be on site from 7.30am – 9.00am on sale day for anyone seeking a second opinion.

Faults which will exclude are:

- (a) All Rigs, cudspillers, undershot and overshot jaws.
- (b) Rams affected with sore mouth or lameness.
- (c) Rams deemed to be unsound or substandard.
- (d) Rams deemed to show current or past infection of CLA will be rejected.

THE INSPECTORS DECISION WILL BE FINAL

All rams rejected by the panel which are not removed from the Vendors sale pen I hour prior to the sale starting will be marked with a purple stripe down the back and will not be allowed to pass through the sale ring.

- 10. Complaints under 9 (a) as above must be notified to the Auctioneer within seven days. Complaints under 9 (b, c) as above must be notified within forty-eight hours. All complaints must be accompanied by a veterinary certificate.
- 11. All rams are warranted to be capable of or effective at natural service. If any such ram is proved to be incapable of or ineffective at natural service and written notice to that effect, supported by a veterinary surgeon's certificate in the terms hereinafter mentioned, is given by the Purchaser to the auctioneers by the 1st November 2023 then the Purchaser may return the ram to the Vendor, who shall, at the Purchasers option, replace the ram with another ram of equal value capable of and effective at natural service, or refund the purchase price of the animal. Save as aforesaid the Vendor shall be under no liability to the Purchaser. If a ram is proved to be incapable of or ineffective at natural service then the vet charges are to be met by the vendor and the cost of returning the ram to be paid by the Purchaser.

The veterinary surgeons certificate shall certify,

- a) That the ram's incapacity or effectiveness is not the result of injury, accident or illness happening after the time of the sale.
- b) That the Purchasers normal breeding stock have been found on examination to be in normal breeding condition; and
- c) That the they are not responsible for ram's incapacity or effectiveness
- d) Rams to be tested using the artificial vagina method.

THE FINAL ONUS REMAINS WITH THE PURCHASER, even though every care is taken and the Association will do its utmost to check animals for defects.

N. B. The Purchaser shall have no rights to claim damages from the Vendor, in respect of an indirect or consequential loss such as (but not limited to) loss of profit or any other loss whatsoever.

- 12. An Auctioneers invoice will be handed to the Purchaser upon completion. This must be shown to the Vendor, on transfer of the sheep.
- 13. All Vendors shall be responsible for their sheep until 5.00 p.m. or 1 hour after the close of Sale if later, or until the sheep have been handed over to the Purchaser to the satisfaction of the Vendor. IF PURCHASERS HAVE NOT CLAIMED SHEEP BY 5.00 P.M. or 1 hour after, VENDORS MUST INFORM EITHER THE AUCTIONEERS CONCERNED OR THE N.S.A. OFFICIALS.
- 14. In the interest of the smooth running of the event, kindly observe instructions from N.S.A. Stewards and follow directional signs as appropriate.
- 15. MAEDI VISNA ACCREDITATION

Vendors of the sheep in the Maedi Visna Accreditation section are required to comply with the rules set out by the S.A.C.

- a) All sheep must be accompanied with a current S.A.C. certificate of M.V. Accreditation.
- b) No sheep will be accepted in the M.V. section without one of these forms.
- c) Care must be taken by the Vendor and Purchaser not to infringe the M. V. rules and regulations. Whilst every care will be taken by the Ram Sale Committee and the Auctioneers, they cannot take responsibility for any infringement, carelessness or consequences there from.

M.V. Accredited forms will be collected by a N.S.A. Steward before entry to the Livestock Centre:

#### 16. Please have your forms ready for collection.

Movement Licences are required which must be from your Trading Standards Offices.

Sheep Movement Forms should be handed into your Auctioneer.

Please be aware of DEFRA regulations regarding the movement and your own clothing. <u>All</u> sheep <u>must be</u> licensed to the sale and licensed out <u>including</u> unsold sheep. Overnight accommodation is available for sheep, for those wishing to come the day before. Catering will be available on sale day.

#### **VERY IMPORTANT**

Vendors are advised not to unload any sheep at the sale before obtaining clear instruction from the Sale Stewards regarding unloading points and correct penning arrangements.


