Except where otherwise stated by the Auctioneers at the time of sale, these conditions shall be binding on both vendors and purchasers of all classes of stock at this sale. All persons buying and selling such stock shall be deemed to do so with full knowledge of these conditions and such stock will be accepted for sale only on that understanding.

ALL CLAIMS FOR BREACH OF WARRANTY MUST BE MADE TO THE AUCTIONEERS WITHIN ONE HOUR OF THE CLOSE OF AUCTION AND BEFORE THE ANIMALS HAVE LEFT THE SALE YARD.

NO CLAIMS WILL BE ACCEPTED AFTER THIS TIME

ALL CLAIMS FOR BREACH OF WARRANTY shall be settled by a person nominated by T.F.A.M. Such person shall have power to order the return to vendor of any animals which he finds do not comply with the warranty and he may order the payment of costs and expenses by the third party and/or compensation or, if time allows on the day of sale, resale by auction of the entire lot with all faults described. All animals must pass through the sale ring and be offered for public auction. Private Sales will not be permitted.

Every vendor MUST ensure their sheep are penned in the correct pens BEFORE they are sold. The number of sheep in each lot shall be counted once leaving the pen to the ring and confirmed returning back from ring.

IMPORTANT

The time mentioned for making claims for breach of warranty must strictly be adhered to and no claim will be admitted if made out of time. The onus of providing that the claim is made within the proper time shall be on the person making it.

EWES & THEAVES

ALL EWES AND THEAVES sold in this fair shall (unless otherwise stated at the time of sale) be warranted by the vendor to be right and straight. The term 'right and straight' means that Ewes and Theaves are CORRECT IN THEIR TEATS AND UDDERS and CORRECT IN THE MOUTH. Ages will be referred by the age in years or shears etc.

Vendors offering ewes of varying ages in one lot MUST disclose the number of ewes in each age group.

Claims of breach of warranty of the above having been provided, the purchaser shall have the option of leaving such animal(s), otherwise the vendor shall pay compensation as defined in the LAA conditions of sale.

LAMBS

*Unless otherwise stated it will be assumed that ALL WHETHER LAMBS ARE PROPERLY CASTRATED.

*Any complaint as to whether lambs have been misrepresented as ewe lambs must be made by the time stated above.

Claims for breach of warranty under the above having been proved, the vendor shall pay to the purchaser compensation at the rate of 33% of the purchase price.

E.I.D

Sellers and Buyers must give particular note to the new LAA conditions of sale regarding liability as shown in the sales office.

PAYMENT: All stock must be paid for on the day of sale. Terms are strictly CASH or CARD unless credit references have been cleared with the Auctioneers prior to the day of sale for payment by cheque. Cheques will be accepted from regular customers known to the Auctioneers.

AGENT RESPONSIBILITIES: Persons purchasing on behalf of a third party are responsible for any debts incurred by the third party in accordance with the Conditions of Sale as laid down by the Livestock Auctioneers Association.

WARRANTY OF STOCK: All stock sold under the LAA Conditions of Sale as displayed in the sheep fair office and those within this catalogue.

Confusion may often be avoided if alterations and amendments to catalogue particulars and other information of value are carefully noted when announced by the auctioneer at the time of sale.

REMOVAL OF SHEEP: It would be appreciated if all sheep could be removed the same day.

MORTALITY WARRANTY is charged to both purchaser and vendor at 20p per sheep sold at this fair valid from seven days from day of sale (please read conditions printed in this catalogue). **Purchasers wishing not to pay the Mortality Warranty must be aware all sheep are at the purchaser's risk once they have left the sale ground.**

BIO-SECURITY AT THIS SALE

Please adhere to the current bio-security regulations – enter sale area clean and leave sale area clean. Foot baths and washing facilities are available.

Information for sellers

- Rams to be penned by 9am for inspection in the pens. The market opens at 6.30am. Penning is free of charge and under cover where possible. The market prefers rams to be penned on sawdust, which is provided, but will allow vendors to bed on straw if they wish. Vendors must supply their own forage.
- Vendors are advised not to unload any sheep at the sale before obtaining clear instructions from the sale stewards. Kindly observe instructions from stewards and follow direction signs as appropriate.
- Stock movement forms and any relevant licenses must accompany all sheep.
- Vendors of sheep are asked to comply strictly with the rules as set out by SRUC Maedi Visna Scheme. All sheep must be accompanied by official certificates of MV status.
- Rams must be identified by means of a clearly marked paint brand lot number.
- **The market will not provide lot numbers.**
- It is the responsibility of vendors to take their rams, in catalogue order, to the collecting pen in good time prior to entry to the sale ring.
- Vendors must make sure their rams have sold before leaving the market.

Pre-sale inspection and general information

- All rams will be sold subject to an inspection by the NSA. Inspection is a condition of entry to the sale but compliance with this inspection shall in no way form a guarantee to the purchaser of the animals so inspected. All rejected sheep must be removed from the sale pens. They cannot pass through the sale ring. Rejected sheep showing lesions suggestive of caseous lymphadenitis (CLA) must be removed from the sale pens immediately.
- **Though care is taken to inspect every ram for defects, the final onus remains with the purchaser.**
- Inspection of rams will start no earlier than 8.30am. The inspectors will consider the following for each ram: identification is as required by legislation; not suffering from any infectious or contagious disease; two adequately sized testicles of approximately the same size and normal consistency; of a quality commensurate with the level set by the NSA South East Region Committee, of adequate weight for the age, and showing no malformation in structure; teeth are in the correct position; and no abnormal deviation in the structure of feet and/or legs.
- All sheep must also comply with any Defra regulations in force at the time of sale.
- All rams entered into the sale are MV-accredited. Care must be taken by vendors and purchasers not to infringe MV rules and regulations. While every care will be taken by the NSA South East Region Committee and the Auctioneers, neither can take responsibility for any infringements, carelessness or consequences arising therefrom.

Sale information

- Selling will commence at 12 noon.
- All rams are sold subject to the Livestock Auctioneers Association (LAA) conditions of sale and the NSA South East Region Rugby Ram Sale bylaws.
- There will be an upstart price of £200 for ram lambs and £300 for older rams, unless the vendor has provided written reserves to the auctioneer to set a higher minimum price for an individual ram. Charges for vendors will be 5% commission plus £1 per ram mortality warranty. Charges for purchasers will be an optional £1 per ram mortality warranty. The warranty will cover rams for seven days against death from natural causes.
- No rams shall be sold on the premises by private treaty other than those which have been offered for sale in the ring first. All rams sold by private treaty after leaving the ring must not be below the upstart price and must be booked through the auctioneer with the appropriate commission paid.
- Complaints must be notified to the auctioneers within one hour of the end of the sale or before removal from the market, whichever is the sooner. The purchaser shall have no rights to claim damages from the vendor in respect of indirect or consequential loss such as (but not limited to) loss of profit or any other loss whatsoever.
- An Auctioneers Slip shall be handed to the purchaser upon completion and also pass out slips for sheep not sold. These must be retained carefully for inspection by stewards until final departure from the ground. All stock, sold and unsold, must be cleared by 6.30pm.
- NSA accepts no responsibility whatsoever for loss, injury or damage to any persons or their property.
