



NSA and Register of Sheep Advisers (RoSA) mentoring competition 2025

Terms and Conditions

These terms and conditions apply to a competition offering up to three hours of free advice to a maximum of six sheep farmers under the age of 35 currently living and working within the UK with an active role in the UK sheep sector. The advice will be delivered in person, via telephone or video conference, dependant on the winners' locations and advice sought from sheep advisers who are current members of the Register of Sheep Advisers (RoSA).

The winning sheep farmers will be selected at random, provided they meet all of the criteria mentioned above and can be successfully matched with an appropriate RoSA Adviser.

Terms and conditions

By completing the application form you agree to the following:

- I am a UK resident with an active role in the UK sheep sector.
- I understand I am applying to receive three hours of free mentoring from an adviser allocated by NSA from the Register of Sheep Advisers (RoSA) – I am not able to choose which adviser I am matched with or if the advice is provided in person, by phone or via Zoom, as this will depend on my location and the location of the most suitable adviser. I can discuss with the adviser if the three hours is most suitable in one block or separate sessions.
- If I am one of the successful applicants, I understand the information provided in this application form may be used by NSA and RoSA in press and publicity. I agree to take part in associated press and publicity and understand the offer of free advice may be withdrawn if I do not participate in press and publicity, including an interview that will be featured in NSA Sheep Farmer magazine about the advisory process and my current sheep farming enterprise. I also agree to supply relevant photographs for press and publicity.
- If I am one of the successful applicants, I understand no monetary alternative is offered in place of the advice.
- If I am one of the successful applicants, I understand the free advice is given in good faith and it is entirely my decision if I take any subsequent action(s). NSA, RoSA and the allocated RoSA adviser cannot be held responsible for any action or reason arising from the views expressed and the information provided by the adviser.
